ENTRIES MAY ONLY BE RECEIVED THROUGH THE CFA ONLINE ENTRY FORM ON THE CFA WEBSITE.

Make all checks payable in US Funds to SACRED CAT OF BURMA FANCIERS, INC PayPal payments can be made to kat4962@aol.com using the Friends and Family option. The club will not be responsible for any PayPal fees. Fees for all entries must be received by the start of the show. Cash accepted at door. Noncollectable checks assessed an additional \$50 fee. Please verify with the entry clerk that your entries were received. ONE BENCHING REQUEST PER EXHIBITOR WILL BE HONORED. IF POSSIBLE AND MUST BE MADE AT TIME OF ENTRY.

All entries must be at least 4 months old; all household pet entries 8 months or older must be neutered or spayed. Owners of cats/kittens without registration numbers can contact the entry clerk for a temporary registration number (TRN).

Health: It is strongly advised that, *before entry*, all cats and kittens entered or present in the show hall be tested and found negative for FeLV, and be inoculated by a licensed veterinarian against panleukopenia (formerly called feline distemper or feline infectious enteritis), feline rhinotracheitis, calici, and rabies. ALL CLAWS OF ALL ENTRIES MUST BE CLIPPED PRIOR TO BENCHING.

At show time, we will follow all current CFA COVID policies and Ohio health mandates.

Benching: will be from 7:30 to 8:30 on Saturday and Sunday with judging to start at 9:am. Any cat(s) not checked in by 8:30 will be marked absent. No refunds for failure to bench. Benching cage size is 22x22x22. Litter provided, bring own pans.

Scoring: All entries in Championship (except Novice), Premiership (except Novice), Agility, registered Kittens, registered Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards.

Rosettes will be awarded per CFA rules. Permanent flats will be used - cloth ribbons available.

Miscellaneous: People food will be available. There is no watchman on duty Saturday night. Show management will take reasonable care of cats and carriers but will not be responsible for damage or loss. This is a NON-SMOKING facility. Smoking of any kind (including but not limited to cigarettes, cigars, e-cigarettes and vaping) is not permitted.
